DFCC Prestige Proposition – Terms and Conditions

- 1. I agree that benefits associated with this DFCC Prestige Proposition is offered under one or several of the conditions:
 - 1.1 Holds a fixed deposit of Rs.2,500,000.00 (Rupees Two Million Five Hundred Thousand) or equivalent in FCY for a minimum tenor of 1 year.
